### Dear Pennsylvania Families:

We would like to take this opportunity to let you know your family may qualify for a scholarship to help defray the cost of your child's preschool tuition. These funds have been donated by area businesses through the Educational Improvement Tax Credit program, and are administered through the Barber National Institute. Scholarship requests of \$1,000 or less will be accepted on an ongoing basis for the 2023-2024 school year until grant funds have been exhausted. Please note that there are a <u>limited</u> number of scholarships available and you will receive a letter of notification either way to let you know if your application has been approved or declined.

Applying for a scholarship is quick and easy, and an application and instructions are attached. Scholarships may be awarded for tuition to any pre-kindergarten program in Pennsylvania that has chosen to participate with us for this coming school year. The student must be a resident of Pennsylvania who is at least three years of age. Income eligibility will be determined from the State's household income limit calculations and our Finance Department.

Please note this is a change in the submittal date from previous years. Applications will only be accepted via email and fax this year, so please plan accordingly. If we receive any applications before 10:00AM on Friday, July 28th, we will have to reject them.
